The meeting was called to order at 2:00 p.m. by Chairman Beaumont after ascertaining that the Notice of Meeting had been posted in accordance with the law. Commissioner Vincent gave the invocation.

#### Minutes of Meeting No. 2373

The Minutes of Meeting No. 2373 was approved as read.

Consider Change Order for Diesel Engine Reduction Gear for Ninth Avenue Pump Station (Pump Station #19)

Mr. Phil Kelley stated that this request for a change order is on one of the four engine and gears that are on order under contract. Mr. Dean Depew advised that, according to the Cummins representative, the gear for the engine was damaged or lost during shipment. A letter received from Cummins gave two options. The first option was

to start from scratch, which would take an additional 28 weeks. The second option was to have the gear custom built in New Orleans for an additional \$4,400.00. With the

proposed time frame for each option, Mr. Kelley stated that it would be worth paying the

additional cost to get the engine installed sooner. Mr. Depew advised that the smaller

engine ordered under the same contract should be delivered this week. Mr. Kelley

recommends approving the change order to increase the total contract amount by

\$4,400.00.

Commissioner Gamble moved to approve the Change Order for the Diesel Engine Reduction Gears for the Ninth Avenue Pump Station. Commissioner Vincent seconded the motion. The motion carried.

Sabine Pass to Galveston Bay Project Summary

Mr. Brady Girouard advised that the District met with the impending General for the Southwest Division and Colonel for Galveston District of the United States Corps of Engineers. The group toured the district and discussed finances and strategies regarding real estate acquisitions and the Phase II Environmental Study. Site visits were held at Contracts 1, 2, 3, and 3B. The District is engaged in property acquisition talks with Kansas City Southern Railroad, City of Port Arthur and the Port of Port Arthur in an effort to allow the Corps of Engineers to advertise with the potential award of Contract 3B in September.
