The meeting was called to order at 2:00 p.m. by Chairman Beaumont after ascertaining that the Notice of Meeting had been posted in accordance with the law. Commissioner Champagne gave the invocation.

Minutes of Meeting No. 2405

The Minutes of Meeting No. 2405 was approved as read.

Receive, Open and Read the Names of Responding Firms to Request for Qualifications for Engineering Services for FY 2021 and FY 2023 HMGP, BRIC and/or FMA Projects

Mr. Phil Kelley stated the District advertised for Request for Qualifications for Engineering Services for FY 2021 and FY 2023 HMGP, BRIC and/or FMA Projects. Engineering Services are required to begin the project development of these projects. Each of the responding firms will be scored by a committee put together by the District according to grant requirements and will return a recommendation for award to the Board

for consideration. There are no monetary values associated with the request for qualifications. Mr. Kelley proceeded to receive, open, and read the names of the responding firms to the Request for Qualifications for Engineering Services as follows:

Freese & Nichols Engineering

Guage Engineering, LLC

LJA Engineering Services, Inc.

RRP Consulting Engineers, LLC

Schaumburg & Polk, Inc.

<u>Consider Resolution Authorizing Master Professional Services Agreement with Freese and Nichols, Inc.</u>

Resolution No. 506 Authorizing Master Professional Services Agreement with Freese and Nichols, Inc. was presented to the Board for consideration. Mr. Allen Sims stated that the District requested that the Corps include penetrations in the seawall to allow for an expansion or rebuild of the Shreveport Pump Station. During the design phase, the requested penetrations were eliminated from the plans. The District has since received a grant to rebuild the Shreveport Pump Station. The Corps agreed to pay the costs to reincorporate the penetrations in the plans. However, it would take six to nine months, possibly a year, to modify the contract or the District could complete the project and receive credit for work in kind. If the District completes the project, the turnaround time is four to six weeks instead of the six to nine months projected by the Corps. Due to the projected time frames, it is recommended that the project be completed in-house as opposed to modifying the contract with the Corps. The project's estimated cost is \$85,000. Freese & Nichols, Inc. is working on miscellaneous projects as well as projects associated with the Sabine Pass to Galveston Bay Project. Therefore, the District asked

for a general services agreement which enables the District to hire them to work on projects outside of the Sabine Pass to Galveston Bay Project. Mr. Kelley stated that Freese & Nichols is the lead firm of a joint venture group that is working on the design of the Shreveport Pump Station contract, so they are familiar with the project.

Commissioner Vincent moved to approve the Resolution Authorizing the Master Professional Services Agreement with Freese and Nichols, Inc. Commissioner Champagne seconded the motion. The motion carried. A copy of Resolution No. 506 is attached hereto and made a part hereof.

Sabine Pass to Galveston Bay Project Summary

Mr. Brady Girouard stated that design, work-in-kind, negotiations for rights of entry with landowners and project meetings continue on contracts. No significant changes since last report. Mr. Kelley stated that soil samples still need to be collected and analyzed by LJA Environmental to determine where and how the potential waste will be handled for Contract 3.

Manager Reports

Mr. Kelley stated that earlier this year he was authorized through a resolution by the board to execute property acquisitions relating to Sabine Pass to Galveston Bay Project. Mr. Kelley stated that the District will be paying Motiva approximately \$26 million of GLO funds to begin the relocation of the main pipe rack. The early construction phase should begin late December or early January which entails relocating a gate structure, a small pump house and part of the control room. The District has already given Motiva \$7 million for engineering fees for this portion of the project.
